AAUWSF Presents Crossing the Line Research at Conference

Cathy Corcoran, President AAUW San Francisco, participated on the panel Advocating for Girls Health and Safety at the Alliance for Girls Annual Conference on May 28th. During the panel, Cathy presented the 2011 AAUW research Crossing the Line: Sexual Harassment at School. Cathy noted how girls' ability to learn is especially impacted by sexual harassment that occurs both in person and online. Attendees received copies of the Executive Summary of the report, as well as the AAUW Title IX fact sheet. The panel included Elizabeth Kristen, Legal-Aid Society Employment Law Center, Kiki Williams, Equal Rights Advocates and Esther Lucero, California Consortium of Urban Indian Health. A lively Q&A session followed and volunteers were encouraged to assess their local high schools for compliance with Title IX, utilizing a helpful checklist created by the California Title IX Coalition. Public Policy Notes

Alliance for Girls 2nd Annual Conference

I attended this idea-laden gathering of leaders from 60 girl-serving organizations (AAUW San Francisco is a member); branch President Cathy Corcoran was a featured speaker and panelist on health and safety for girls.

Cathy presenting key findings of *Crossing the Line*, AAUW's landmark study on sexual harassment in schools. She deftly answered a question from the audience about why male students experience "gay" slurs, by noting that when a boy is called gay, it's bullying designed to emasculate him.

Although she couldn't be at the May meeting in person, Renee Golanty-Koel, long-time branch member, co-lead of the branch's Sister to Sister program and contributor to Tech Trek, received a commendation from the San Francisco Commission on the Status of Women for her distinguished service and advocacy on behalf of women, families and children.

Also at the Commission meeting: SF Department of Children, Youth and their Families reported that more than \$2m in grant funding is being allocated to girl-specific programs. Prior to this the Department did not distinguish between programs for girls and boys.

White House Regional Summit on Working Families

A key theme resonating throughout this half-day event: "When women succeed, America succeeds!" San Francisco Mayor Ed Lee, Leader Nancy Pelosi and Representative Jackie Speier were among the key speakers.

My favorite quotes: Lee — "Equal pay is a San Francisco value." Pelosi — "Leadership means giving voice to the voiceless." ..and.. "You shouldn't have to win the lottery to be a good parent." Speier — "We're not going to live in a *Mad Men* episode." Other speakers noted that only three states have paid family leave (California, New Jersey, Rhode Island), forcing workers in all other states to choose between financial security for their family and their health, or caring for a loved one.

Before Helen, There Was Grace Pat Camarena

Helen Thomas, a Detroit native who passed on in the summer of 2013, had the distinction of being the first female member of the White House Press Corps and the first female officer of the National Press Club. She was also became the president of the White House Correspondents Association. However, before Helen sat front row center at White House press conferences for so many years, countless women, often unrecognized, had contributed to the growth of American journalism as the momentous events of our national history unfolded.

One of these women was Sara Jane Clarke. Born in New York State in 1823, the daughter of a physician, Sara Jane was one of the first women to gain access into the Congressional press galleries. With this access, she used her questions to advocate for social reform and women's rights. A long time writer of poetry and children stories, she was published frequently in widely read current magazines. Sara Jane Clarke, otherwise known by her pen name of Grace Greenwood, was the first woman reporter on the New York Times payroll. She wrote travel pieces initially from the West and

Europe. A staunch abolitionist, whom Lincoln called his "Little Patriot", Sara rubbed shoulders with other prominent members of the literary society of New York such as Julia Ward Howe and Mary Mapes Dodge. Sara also wrote and lectured on women's rights issues such as equal pay for equal work. In the 1880s she lived in Europe for half a decade, with her daughter, working for the London Journal while writing a biography of Queen Victoria.

As journalism became a profession, women were restricted by custom and by law from access to journalistic professions. They were faced with significant discrimination within their job category. In spite of these handicaps, women such as Sara (Grace Greenwood, operated as journalists before the start of the 1900s.

Playing Now Paula Campbell

Theresa Rebeck's Seminar, now at the could easily have been titled SFPlayhouse, "Masochism." We meet four young hopefuls signed up for a seminar in writing, conducted by a much lauded author (though he hasn't produced much recently.) Much like in Terrence McNally's Master Class, (students signed up for a class with Maria Callas), the teacher eviscerates the students. Callas asks a student to sing, then stops her after one note - our Famous Author asks a student to read her new work, then stops her before she gets through the first sentence. But the students keep coming back for more. "Please sir," (to paraphrase the famous line from the musical Oliver), "more abuse." At \$5000 a pop, and with the seminar taught in the apartment of one of the students, our FA seems to be raking it in. And since he's male, there is the added bonus of seducing female students. We learn our FA has been involved in professional misbehavior, and is not really as confident as he seems, much as Callas, in Master

<u>Class</u>, soon starts to mourn her failed relationship with Onassis, and her clearly diminishing powers. Can we all say "derivative"?

Nonetheless, Seminar is well worth seeing. The writing is crisp, clear, and funny as hell. characters are well fleshed out, and hold our interest. Lauren English, Natalie Mitchell, Patrick Russell, and James Wagner, our four students, make the most of their juicy roles. Each of the four is outstanding, creating real people we believe in, sympathize with, and in the case of this reviewer, want to protect. All this is dependent on the actor who plays the FA. The play revolves around him; the other characters' reactions to him are what move the plot forward. That's a heavy load for an actor. On Broadway the role was filled by twice Tony Award winner, Alan Rickman. Charles Shaw Robinson plays him in this production, and is more than up to the task. It's a difficult role – the FA is predatory, nasty, and often cruel, yet the actor must also project his vulnerability and make his appeal to his female students something the audience can accept. Robinson does it in spades. His FA is nuanced, layered, multifaceted. It's a beautiful performance.

<u>Seminar</u> is directed by Amy Glazer, recipient of many awards, both stage and film. She's directed many productions at SFPlayhouse, and other Bay Area theatres.

The detailed set is by Bill English, who, as always, provides us with a feast for the eyes, and with a big surprise in the last part of the play. As this reviewer has reminded you before – the man is a genius!

Seminar moves quickly, involves the audience completely, and is certainly something not to be missed.

Marie Curie & AAUW

The year was 1919. Europe had been ravaged by World War I and radium was far too expensive for a scientist of modest means to afford for experiments. This was true even forone as famous as Madame Marie Curie. As a result, her groundbreaking research had reached a virtual standstill. Then the AAUW came to the rescue. Members from Maine to California helped raise an astonishing \$156,413, enabling Madame Curie to purchase one gram of radium and continue her experiments that helped her create the field of nuclear chemistry and forever change the course of science. Madame Curie received the Nobel Prize for her work, but was not admitted to the French Academie des Sciences until she won an incredible second Nobel Prize...all because she was a woman. More than 75 years later, there are still only three women members.

Pay Equity

AAUW has been on the front lines fighting for Pay Equity for over a hundred years.

AAUW was there in the Oval Office in 1963 when President John F. Kennedy signed the Equal Pay Act into law.

AAUW was there in 2009 when President Barack Obama signed the Lilly Ledbetter Fair Play Act into law.

AAUW continues the fight for the passage of the Paycheck Fairness Act to ensure women have further equal pay protections. The pay gap is real.

AAUW will continue the fight to achieve pay equity; the economic security of American families depends on it.

Legal Advocacy Fund

Founded in 1981, the Legal Advocacy Fund (LAF) works to achieve equity for women in higher education by recognizing indicative efforts to improve the climate for women on campus; by offering assistance to women faculty, staff, and students who have grievances against colleges and universities; and by supporting sex discrimination lawsuits.

The LAF Board only approves support of cases which are currently involved in litigation, and that have the potential to set legal precedent.

The Legal Advocacy Fund's annual Progress in Equity Award recognizes indicative and replicable college and university programs.
